Letter from the President

I have been thinking about safety here in the Glen lately.

Each summer we see news about wildfires in Southern California areas. Many of our long-time residents are fully aware that we live in an "Urban Forest". However I know we have new neighbors every year move to this lovely "country in the city" spot.

Have you seen the signs that dot the roadside that tell you that open burning or smoking are NOT allowed? The exact wording of the ordinance in the Los Angeles Municipal Code is: SEC. 57.25.02. POSTING OF SIGNS PROHIBITING SMOKING AND BURNING. (Amended by Ord. No. 176,943, Eff. 10/5/05.)

"There shall be no open burning or smoking in the Very High Fire Hazard Severity Zone. The Chief shall cause such districts to be posted at all times by suitable signs giving notice thereof."

There are several points in this section of the code that include the requirements that seem logical to long time California residents, such as SEC. 57.25.14 "No

person shall throw or place, or cause to be thrown or placed, any lighted match, cigar, cigarette, ashes, or other flaming or glowing substances, or thing in any place where it may directly or indirectly start a fire." This is common sense right? Yet as my Dad always reminded me, "Common sense is not so common anymore." Laws like these would not be needed if all people acted with concern for themselves AND their families, neighbors, and community.

We are in the high fire season now. Remember to keep your property cleared of any dried grasses, dead plant material, dead trees, trash, boxes (anything that would fuel a fire). Water your plants and land regularly as DWP allows, and be careful if you use a BBQ (open areas are best). No smoking in the canyons and hillsides... Beverly Glen is a canyon and hillside, not just a street.

Have a safe and fun summer! Enjoy our wonderful weather! Get out there, walk and drink in the beauty of our Glen!

Report on April, May and June Meetings

Voting

RoBG continues to work with our Councilman's office to get the City and County Clerk to change the voting precincts back to what they were to avoid any confusion and to make it easier for our residents to vote.

Public Safety

Our Senior Lead Officer, Chris Ragsdale, informed BABCNC about a slight increase in crime in our area: burglaries, trespassing etc. Keep vigilant; it's a safe area, but don't make yourself an easy target. If someone comes posing as a utility or other worker when you did not order the service, don't let him/her in, and call the utility to confirm. Use the West LAPD Five Points of contact found on our website for direct numbers, <http://beverlyglen.org/2011/02/01/west-lapd-points-of-contact/>.

Budget

Our own BABCNC Vice President, Ron Galperin, who has spent months chairing the Ad Hoc Committee on Revenue Enhancement (CORE) has had the recommendations approved by Council and we hope it will go a long way to help fill our budget gap.

New Mayor's Representative

BABCNC is pleased to welcome Joseph Hari on his new role as the Mayor's Westside Representative. Although Joseph has a large area to cover, we trust he will make sure our hillside areas get the Mayor's attention.

Potholes

As some may have noticed, there was a "Pothole Patrol" in early June that filled potholes around the City. As always, contact Bureau of Street Services, <http://bss.lacity.org/>, for pothole repairs or requests to resurface streets.

Sewer Fees

Yes, the City does need to raise sewer fees to comply with Federal laws on our wastewater systems. They estimate it will be an average of \$37/year/household. If you don't already know, your wastewater is based on your water usage. If you have a lot of landscaping, consider looking into using a separate meter, or contact DPW about how to better estimate your water usage and thus your sewer fees.

Planning and Land Use

Our new Planning Director, Michael LoGrande, attended the April meeting to discuss his vision and blueprint for the City's Planning department, which can be found under the Reorganization section of their website. With his background as Chief Zoning Administrator, Michael brings deep knowledge of the everyday issues that mostly affect our area.

Code Simplification Ordinance

This proposed ordinance is aimed at making certain findings and approvals easier Citywide. There are certainly ways the City can help make it easier for residents and businesses to responsibly grow, and RoBG has pointed out issues regarding language that could lower the hurdle for some developments in our area. "Clean Hands" Ordinance

BABCNC approved a motion to request that the City adopt a "Clean Hands" ordinance similar to that currently in use by the County, which essentially specifies that a project cannot get any other permits or approvals until it has the right zoning approvals.

10291 & 10297 Mariel Lane

The project was heard by BABCNC Planning and Land Use and was opposed on all requests: front and side yard setbacks. The public hearing was held on May 10, 2011, and the City currently has the project on hold.

Hillside Federation Update:

Retaining Wall Ordinance

At the July Hillside Federation meeting the Department of City Planning gave a presentation of its plans to initiate a new **Retaining Wall Ordinance**. City staff will be conducting public outreach meetings to obtain input from the individuals, groups and associations involved. We have invited them to tour the community to see retaining walls in our neighborhood. They are also working to create a database of photos that show a variety of retaining walls. If you have any photos of walls that you can share, please email them to hillside@beverlyglen.org. If you happen to know any details about the wall (e.g., height) please include that in the email. Upper Stone Canyon Reservoir Water Quality Improvement Project

This LADWP project is important as it affects our community in many ways. As required by the EPA, Upper Stone Canyon Reservoir must be covered to protect drinking water supplies. LADWP has released its draft EIR, and the preferred project would construct a new buried concrete-covered reservoir with 3 ft of topsoil and shallow rooting plant species typical of the canyon. It would allow very limited recreation in the form of trails, to be operated by LADPR and/or the Santa Monica Mountains Conservancy. TRAFFIC

We survived Carmageddon! We hope that those who travelled along Beverly Glen for the first time when they closed the 405 will be respectful of our community if they come through here again. You can help increase the chances of that by maintaining the 30 mph speed limit when you drive Beverly Glen!

The goal of the traffic committee is to promote the safety of those of us who live here. We're out there trying to slow traffic down! You may see some Residents of Beverly Glen volunteers in bright yellow vests with the LAPD speed radar gun. We have been trained and will send lists of speeding vehicles to the LAPD, which will send out letters asking people to abide by the speed limit. You may also see Officer Tim Rolsen out there on his motorcycle, stopping oversize trucks that are using Beverly Glen as a shortcut, instead of using the freeway as they are supposed to use.

Please help us remind the LAPD that we have a speeding problem here – the more they hear from us, the more likely they will come enforce the speed limit! Call LAPD at 213-473-0222 and let them know if you have experienced someone driving too fast or dangerously, like zipping into oncoming traffic to go around a driver going the speed limit. LAPD needs to hear from us. You don't need to give a license plate – just let them know that we need additional speed enforcement in the Glen. Make sure to let Councilman Paul Koretz know that we need more enforcement as well – call his Valley office, 818-

IN THE KITCHEN WITH DIANE

Flourless Chocolate-Chip Zucchini Cookies with Flax Seeds

This is a basic recipe for a healthy cookie. When I make these I don't measure out the ingredients, just use a bit of instinct. I have written this version down for you as a 'starting point'. My preference is for more of a biscuit cookie, not so sweet. You could adjust the sugar to your liking, or add a bit of sugar as a dusting on top. Sometimes I will also add in a bit of blue agave sweetener for a little different flavor. I may also put in some yellow raisins, walnuts or granola etc.

Pre heat oven to 380 degrees.

Mix and stir together:

- 1 cup of toasted oat bran and 1/2 cup roasted whole flax seed (available at Trader Joe's)
 - 1 cup ground flax meal (available at Trader Joe's)
 - 2 cups toasted rolled oats
 - 1 t. baking powder
 - 1/8 t. sea salt (really just a pinch)
 - 3/4 cup brown sugar
- Add:
- 1 cup almond butter (creamy or crunchy)
 - 2 t. vanilla extract
 - 1/2 cup dried cranberries
 - 1 medium zucchini grated
 - 1 cup semi-sweet chocolate-chips
 - 1 cup roasted unsalted sunflower seeds

Stir in 1 1/2 cups cold water and mix well. Form into small balls about 2 inches round (I dip my hands in water for this part so that the dough doesn't stick to my fingers). Roll into whole flax seeds (you may want to add a bit of sugar into the flax seeds if you like a sweeter taste)

Place onto oiled (I use canola oil) cookie sheet (I like the extra thick kind so that the bottoms don't burn) These cookies do not expand, so they can be placed fairly close to each other while baking.

Bake for 15 min at 380 degrees, and then turn down the temperature to 250 degrees for another 15 minutes.

Makes approx 4 doz. cookies.

DANA GLUCKSTEIN, a Photographer for Social Change, LDRCC, Sunday, Sept.25 at 4 pm

Dana will speak about how she has used her photography as a primary vehicle to bring awareness to the important United Nations Declaration on the Rights of Indigenous Peoples to create a campaign for social change. She will discuss how the work has impacted the world with intellect, emotion and artistic content and how she developed an advocacy campaign associated with the images.

Recently, Dana Gluckstein's traveling exhibit, DIGNITY: Tribes in Transition, (which features 60 of the 103 images from her coffee table book) was invited to exhibit at the United Nations in Geneva, to celebrate the recent U.S. support for the UN Declaration on the Rights of Indigenous Peoples. The opening of the exhibition was timed to coincide with the 4th meeting of the Expert Mechanism for the Rights of Indigenous Peoples.
