

## A wonderful Holiday Party was had by all!



### **TRAFFIC**

The goal of the traffic committee is to promote the safety of those of us who live here.

We hope that residents will drive the speed limit (30 mph) through Beverly Glen, setting a good example for our commuting visitors.

Our traffic committee has worked closely with the Los Angeles Police Department, and you may have noticed recently that we have had additional enforcement of the commercial vehicles who use Beverly Glen as a cut-through from the Valley to the Westside. Commercial vehicles are NOT PERMITTED to use Beverly Glen for this purpose. Commercial vehicles (trucks over 6,000 lbs) that have business here in the Glen are, of course, allowed to use this route. Other trucks are not supposed to do so. Our commercial traffic enforcement officer is Tim Rolsen, a 25-year LAPD veteran who is an expert on this issue. You will see him from time to time on his motorcycle stopping large trucks down near Greendale.

If you see trucks from the same company over and over again, please let our traffic committee know the name of the company. For example, we have let Off. Rolsen know that we have seen Town & Country party rental trucks (based in Sherman Oaks) coming through Beverly Glen frequently. Rolsen has been in touch with this company and let them know that

they are not supposed to use Beverly Glen as a freeway alternate for their trucks.

You can help us remind the LAPD that we have a speeding problem here – the more they hear from us, the more likely they will come enforce the speed limit. Call LAPD at 213-473-0222 and let them know if you have experienced someone driving too fast or dangerously, like zipping into oncoming traffic to go around a driver going the speed limit. LAPD needs to hear from us. You don't need to give a license plate – just let them know that we need additional speed enforcement in the Glen.

#### PARKING GARAGE

As many know, the City has proposed leasing various parking garages to private companies in exchange for a lump sum payment in order to help balance the 2010-2011 budget. After much opposition from various community leaders and a strong stance by our Councilmember Paul Koretz, the City is reconsidering this proposition. Although the Mayor strongly

supports it, it presents significant issues particularly to Westwood Village as inexpensive parking is the lifeblood of Westwood Village and its businesses we all visit. BABCNC approved a motion to join various councils and groups, including the West Regional Alliance Council in opposing the proposed P-3 idea. One issue to consider is if the next step will be the parking meters, which have had a dramatic impact in Chicago.

### **Planning Department Changes**

The City is significantly re-organizing the Planning Department and making big changes to how it's run. The goal is for Planning to be more efficient and transparent. ### NBC UNIVERSAL EVOLUTION PLAN

NBC Universal is proposing to build one of the largest infill real estate developments in Los Angeles history at its property at the junction of the 101 and 134 freeways. The project proposes to create 2 million square feet of new commercial development including 500 hotel rooms, almost 3000 residences, studio facilities, and tourist attractions. The project will have significant negative impacts on traffic and air quality in the surrounding areas, however, according to the Draft Environmental Impact Report the project is not expected to have any significant impact on Beverly Glen Blvd traffic. RoBG will continue to monitor and report on any potential impacts to our community as this project develops.

### BASELINE HILLSIDE ORDINANCE

The Baseline Hillside Ordinance (BHO) is still awaiting finalization at the City Attorney's Office. As you may know, the BHO is an important amendment to the Los Angeles Municipal Code that deals with single-family residential zoned lots in hillside areas, attempting to address out-of-scale construction on small or steep hillside lots in Los Angeles, while addressing property rights and other needs. While the BHO has been at the Attorney's Office since August 2010, we expect it will be the end of February 2011 at the earliest before it is finalized.

## GOODBYE TO A LONG-TIME GLENITE

Robert (Bob) Levine, a long-time resident of Beverly Glen, died on December 6, 2010, at UCLA's Medical Center. Bob and his wife, Carol, moved to Beverly Glen thirty-four years ago, buying the house on Chrysanthemum Lane in which they have lived and raised their three sons, David, Peter and Joseph, all of whom attended Playgroup. Bob was best known in the Glen for the energetic and active role he played for many years in the original Beverly Glen Democratic Club (started by Les Rivers) and for his pivotal role in restarting the Club, which is still active. However, Bob played important roles on a broader stage as well.

He had a long and distinguished career as an economist and policy analyst, holding major posts in the federal government and in organizations consulting with the government. As Assistant Director for Research, Planning, Programming, and Budgeting in the Office of Economic Opportunity from 1965-1968, he was chief planner for the "War on Poverty" under Sargent Shriver, and from 1975-1979, he was Deputy Director of the Congressional Budget Office. During these periods, although the Levines lived in Washington D.C., they kept their house in the Glen. When not working for the government, Bob was employed by the RAND Corporation and the Systems Development Corporation, both in Santa Monica, and taught at Yale, UCLA, and Stanford. He will be missed.





### IN THE KITCHEN WITH DIANE

### **Dark Chocolate Sorbet**

I tried experimenting with chocolate sorbets when my husband's favorite chocolate soy sorbet was discontinued at the local Trader Joes. It was Lee's idea to add in the scotch whiskey; which adds a really wonderful undertone of flavor.

It took about six tries to perfect this recipe. At first I had used a double boiler to melt the chocolate (very time consuming). Also, by adding in the nut butter and oil the sorbet becomes less icy. I use a Cuisinart two quart ice cream/sorbet maker for this recipe. At times I will also add in toasted chopped hazelnuts the last 5 minutes (ice cream maker phase). Makes about fourteen ½ cup servings.

4 ½ cups unsweetened soy milk

½ cup organic brown sugar

2 tablespoons pure vanilla extract

10 oz dark chocolate (72% cacao) broken into medium size chunks

Pinch of sea salt

4 tablespoons smooth almond butter

4 tablespoons almond oil or grape seed oil

2-3 tablespoons single malt scotch whiskey (optional)

In a heavy, non-aluminum pan slowly heat the soymilk. Add in all of the ingredients except the vanilla extract and scotch. Whisk at a low heat until all the ingredients are blended and the chocolate is melted (about 5 minutes). Let cool, cover and refrigerate overnight. (This

is called your pudding) The next day stir in the scotch (optional) and vanilla. Put into electric ice cream maker, making sure the frozen bowl is very cold, and mix for 25 min. At this point the sorbet will have a soft texture. If a firmer consistency is desired, put into an airtight container and transfer to the freezer. Remove from the freezer about 10-15 minutes before serving.



### **BENTORNATO, JOE ROSA -WELCOME BACK!**

In 2005 Joe Rosa, the original owner of the Beverly Glen Marketplace, sold the market, retired and moved to Italy. The market had been the cornerstone of the Glen Center, drawing customers to all the merchants. It had the same layout and the same goal as Joe's dad's old store in New Jersey, to analyze the needs of the community and serve it. This Joe did for years, developing the market until he sold it. The new owners copied Joe's management style and everything went well for two or so years, but then business slowed and declined. Suddenly inventory was depleted, charge accounts were stopped, other merchants in the Center were feeling the pinch and the Glen Center landlord was unhappy. The new owners were in default, and the market was in need of a change.

When he found out they wanted to sell, Joe felt a duty to return to Bel Air and restore the

market to its former glory. It was not an easy decision; he was retired in sunny Italy after a lifetime of hard work. But, the community surrounding the market, composed of professionals and entertainment people with a new population of young people, have limited time, and Joe understood that they still need the convenience they became accustomed to a few years ago.

Once again serving neighbors in Beverly Glen, Bel Air, Brentwood, Sherman Oaks and the Valley, Joe will provide a full neighborhood market, prime and choice meat, a deli for prepared foods and take-out, a bakery, a full line of groceries and a wine and spirits enoteca. He says his goal is not only to restore the market but to take it to the next level.

Joe still maintains his home in Italy and plans to go back for a week or so at a time, once the market is rolling. He admits he's never satisfied, always striving to serve the community better. He's proud that he's made many friends here over 30 years, and watched their children grow up, people who still come in to say hello, not only to buy something, but to chat. Be sure to stop by the market and ask for Joe, and remember to say you read about him in "The Glenite".
