presented by our State Assembly Member, Mr. Mike Feuer. As this is Mr. Feuer's last term as our State Assembly Member, he very graciously presented each board member with a proclamation of community service as well.

Special guest Paul Edelman spoke regarding measures HH and MM on the November 6th ballot, both of which passed. The special assessments created by these two measures will allow the

Mountains Recreation and Conservation Authority to continue acquiring land and providing essential services in the Santa Monica Mountains, including trash pickup; maintenance of over looks, trails, watersheds; ongoing land, water quality and wildlife protection services; and fire prevention services, ranger services and patrol.

Measure HH proposed a \$24 per year assessment on parcels from the 405 east to Griffith Park, and funds will be earmarked for services in that area of the Santa Monica Mountains. Total assessments for this district will come to about \$685,000 a year.

> Measure MM proposed a \$19 per year assessment on parcels west of the 405, from Mulholland Drive north to the Valley floor, and funds will be earmarked for hillside services in Encino, Tarzana, and Woodland Hills. Total assessments for this district will come to about \$315,000 a year. All assessment money will be locally raised and locally spent. Only developed parcels will be assessed. If a house straddles

May thru October 2012, Meetings

BABCNC CODE OF CIVILITY AND STANDING RULES

After a contentious June meeting that culminated months or years of internal issues, BABCNC engaged the City Department of Neighborhood Empowerment and City Attorney to help resolves some internal conflicts and advise on a road map to allow for proper standing rules and etiquette during meetings. As such, a Code of Civility for Board members and the public has been passed, and a new Ad-Hoc Committee on Standing Rules has been formed to draft recommendations on rules and procedures, not currently in the by-laws, for eventual inclusion in by-laws revisions. Slowly but surely, BABCNC is working to correct these issues; hopefully a healthier Board that represents the community will arise.

Comprised mostly of stakeholder groups, many of our representatives are elected or appointed by their respective stakeholder groups (as RoBG representatives are elected by you at Annual Meetings). However, your voice and input are always welcome; so please visit <u>babenc.org</u> for times and dates of this Ad-Hoc Committee's meetings or attend any of the monthly regular Board meetings and public comment is always welcome.

FRACKING

BABCNC passed a motion supporting Councilman Koretz's efforts to place a moratorium on fracking locally until better controls and environmental impacts can be determined so that this new method can be done safely.

BEL AIR ASSOCIATION

As a side effect of the issues outlined above, Bel Air Association has officially withdrawn its representative from BABCNC. No other stakeholder group has expressed interest in the same action, but we hope that with the work mentioned above, we can provide for an environment for BAA to return.

TRAFFIC

If you think traffic is bad on Beverly Glen, we need you to help do something about it.

Councilman Paul Koretz needs to hear from

us. **Call his office at 818-971-3088** and tell them that Beverly Glen is unsafe for our families due to speeding and oversized truck traffic.

The LAPD needs to hear from us. **Call** the West LA Traffic Division at 213-473-2222 and ask for Sgt. Kunz. Tell him that Beverly Glen is unsafe for our families due to speeding and oversized truck traffic, and that we need additional enforcement for both speeding and commercial vehicles.

We will only get additional LAPD enforcement if we show our Councilman and the police that our community needs to be their priority. More calls = more enforcement. Call today, then call again tomorrow. Then call next week.

The goal of the traffic committee is to promote the safety of those of us who live here.

Please drive the speed limit (30 mph) through Beverly Glen, setting a good example for our commuting visitors.

EMERGENCY PREPAREDNESS

Community Emergency Response Team—"CERT" was created by the Los Angeles Fire Department, first in the entire nation. It is now a program being used in most of the USA. We need to be ready for any disaster that comes our way. What better way to serve our families and immediate community than to be fully trained to be a

community first responder support person? Living in the Glen brings challenges that we need to be aware of and ready for. If trees fall and block N. Beverly Glen, we will not be able to drive out . . . or in. Being prepared is much easier if you are trained, have practiced and have a plan for your family and block. I have included the relevant websites so that you can review the program: http://lafd.org/lafd-cert and http://www.cert-la.com. If you would like to be part of a training session here at the LDRCC, contact me (Dan L. Palmer) at <u>emergency@beverlyglen.org</u>. We need a minimum of 12 people, and you must be 18+ years old to be certified..

Street-Storm Drain Cleaning Time -We have many street drains that are actually "storm drains" along N. Beverly Glen Blvd. We could call some municipal entity to come out and perform this work; however, we know that they do not have money or time to accomplish this task in a timely manner. We take it upon ourselves to do this work that benefits not just us but our community as well. If you are unable to undertake the work, consider assigning your gardener to clean out the storm drain (or any another drain) on or in front of your property. I personally find that it is great exercise raking leaves and shoveling dirt. The time we spend preparing the street drains will benefit us greatly in the rainy season to come.

Home Winter Prep - Let's move on to our homes. Time to clean out the gutters on your house as well. How is your roof? It is much easier to inspect and repair roofs when it is not raining.

HILLSIDE FEDERATION UPDATE

Mayoral Candidate Forum

The Hillside Federation hosted a mayoral candidate forum at its October 2012 meeting. Jan Perry, Kevin James, Eric Garcetti and Wendy Greuel were invited to a Q&A on various topics important to hillside communities. The candidates discussed their respective positions on ridgelines, administrative code enforcement and clean hands ordinance, sign ordinance, traffic issues, and city reform.

Cell Phone Towers

Cell phone towers in residential communities were unregulated until very recently. Telecom providers had previously taken advantage of the City's regulations on placement of utility poles and many communities found poles placed in residential areas with no community input. Members of the Pacific Palisades Residents Association spearheaded reform to eliminate the utility pole exemption and expand notice of any proposed pole to 250 linear feet. The Hillside Federation had long supported this matter.

Digital Billboards

The Hillside Federation continues to be involved in the ever-evolving sign ordinance and recently the issue of digital billboards. Digital billboards are all over the city and have led to complaints about visual blight, light trespass into homes and apartments, and potential traffic hazards. BEVERLY GLEN PLAYGROUP

Beverly Glen Playgroup is a parent-run cooperative preschool located in the heart of Beverly Glen. We occupy the Les and Dorothy River Community Center on Scenario Lane.

Tucked away in a quiet corner of the Glen, Beverly Glen Playgroup endorses a play-based developmental approach to learning, emphasizing the uniqueness of all children and respecting their individual rates of development. We believe that children learn by doing. Our focus is on the process of education versus the end product. In operation since 1946, "Playgroup" is a close-knit community of current students, parents, siblings, and alumni – a warm and supportive extension of home and family.

We offer a morning and afternoon program. Our morning program is for older children (must be 3 years old by September 1st of the school year), and our afternoon program is for younger children (must be 2 years old by September 1st of the school year).

We are currently accepting applications for the 2013-14 school year. Applications must be received by December 15th. As part of the application process, families are required to take a tour of the school before December 15th. The remaining tour dates for this year are Thursdays, November 29th and December 13th.

As a neighborhood school, we try to give priority to Glen families, but they are not guaranteed acceptance. All families must complete their applications on time, attend a tour and be able to fulfill all co-op requirements. Other admissions factors include the need to accommodate gender balance, siblings and alumni.

OUR LOCAL FARMERS MARKET AT THE GLEN CENTRE

D id you brave the rain to shop at the Farmers Market at the Glen Center on the Saturday before Thanksgiving? And if so, were you tempted by the array of Buddha's Hands or the wonderful variety of tree-ripened avocados and vine-ripened tomatoes? I certainly was, as attested to by the large Buddha's Hand (which I discovered was a citrus fruit, not a squash) sitting in the middle of my Thanksgiving arrangement

Our local farmers' market is open on Saturdays from 8 AM to 2 PM. It has been operating for 3 months now and offers an impressive variety of fresh produce, prepared dishes, plants and cut flowers, handicrafts and more. The market is sponsored by Raw Inspiration and managed by California Certified Farmers Markets. Raw Inspiration is a non-profit organization whose mission is to educate children and adults on the importance of a healthy diet that includes eating fresh fruits and vegetables daily. In aid of that mission, they set up programs through which growers can distribute their produce at neighborhood farmers markets. This organization also sponsors a large number of other farmers' markets in the Los Angeles area, including the Brentwood Farmers Market (Sundays) and the Century City Farmers Market (on Thursdays).

As a lover of freshly harvested faire and farmers' markets, and a believer in buying locally and supporting small farmers, I am thrilled to have a farmers' market so close to us in the Glen. Even so, I have not yet fully adjusted my mental calendar to associate Saturdays with shopping there and am sad when I have missed the opportunity. If you haven't yet visited our local farmers' market, I encourage you to do so. Take advantage of the (free) valet parking, and be sure to bring several, large shopping bags... you will fill them!

IN THE KITCHEN WITH DIANE

Roasted Beet Salad

Serves 4

This is one of my favorite recipes that I will make over the weekend and use during the week as a side dish.

Ingredients:

7-8 large dark red beets, trimmed and scrubbed (keep the skin on). I like to use organic if possible; they have much more flavor.

Pre-heat oven to 375 degrees. Place beets on a stainless steel tray, and bake for about 1 1/2 hours or until tender. Cool and peel the skin, it should pull right off. If you prefer the skin on that is ok as well. Dice and put into a bowl. Sprinkle with extra virgin olive oil and a small sprinkle of either fresh lemon juice or red wine vinegar. If you prefer balsamic vinegar, that is good too. Add in a small handful of fresh minced herbs. I use fresh mint with lemon thyme. Parsley and dill are good as well. Season to taste with sea salt and fresh ground pepper. (I like the mixed medley pepper with pink peppercorns).

Serve as is or on a piece of lettuce with a bit of greek yogurt.


