

# Operation NC Blitz (ie. Pothole Repairs)

As you may have seen, we posted the repair request form and submitted to the City, fingers crossed, the Glen gets more than its share of repairs in this area and we all know we need it. Thank you to all who submitted forms, we may not get all but hopefully get something.

### **Bylaws Changes**

In response to Empowerment and part of an overall effort to better reflect who the NC runs currently, BABCNC made changes to its bylaws. Of significance is the Board is now made up of 25 Board members (previously was around 45) and after an authentication process of attendance, will be more of a hybrid make up of active stakeholder groups (like RoBG) and elected positions by territory as well as at-large and various non-residential stakeholders (academic, commercial, religious etc.). The Board will complete this transition over the next few months.

#### RoBG and BABCNC

You'll be happy to know your two RoBG representatives had some of the highest

attendance records in the NCs recent survey and maintaining very active roles (Robert as President and now Vice President, Ramin as Chair of Planning and Land Use). Beverly Glen shows its impressive role in NC including our own Emergency Preparedness Chair, Dan Palmer on the NC Public Safety Committee as well as the recent appointment of local resident Travis Longcore as the representative from the Santa Monica Mountains Conservancy. Go Glenites!

#### **NC Committees**

The Neighborhood Council is not just for Board members, various committees (Land Use, Public Safety, Traffic, Outreach) are all available to any stakeholder. A great way to get involved and help the Council fulfill its role to serve the community in its official advisory capacity to the City. For more information, email babcnc@beverlyglen.org.

### **Party Houses**

LAPD has reported some "party houses" have emerged, homes that are not occupied and leased for commercial purposes. LAPD is looking into this issue as well as the NC Planning and Land Use to determine if this is legal, if you think you live near or next to a "party house", contact our Senior Lead Officer Chris Ragsdale at 26690@lapd.lacity.org. Remember, this is for homes not occupied and being leased regularly for parties, events, weddings, functions etc. If you have noise issues, contact LAPD dispatch at (310) 444-0701.

### **Important Motions**

Charlie's Pantry – BABCNC supported a Zoning Variance to allow a Type 42 liquor license. Though many other tenants expressed concern about parking, was unrelated to the use but BABCNC and RoBG will look into parking issues at the GlenCentre.

**Transit** – BABCNC passed a motion asking Metro to prioritize the Sepulveda Pass Corridor for a transit connector. Currently, it's last in priority and only planned for bus, BABCNC encourages a transit to help alleviate 405 traffic, which many help our traffic situation and give us all a viable alternative method of transportation.

Urban Beekeeping - BABCNC supported Honeylove's (www.honeylove.org) request to codify urban beekeeping as a way to control uncontrolled hives. The motion asks Planning to study the issue.

### **TRAFFIC**

If you live in the Glen, you've seen it. It's there when you wake up in the morning, and it's there when you go to sleep at night. Some of you fall asleep to the sound of it while others get woken up by it. It comes in a variety of colors and generally has two speeds: very slow or very fast. I'm talking, of course, about T-R-A-F-F-I-C.

Perhaps you noticed the brief appearance of the Radar Sign as you travelled

ance of the Radar Sign as you travelled south on Beverly Glen Blvd. near Nicada this past week. We can thank LAPD Officer Chris Blankenship for arranging to have this sign posted. Unfortunately, the sign could only be left up for a few days because (1) the City has a limited number of these signs for the entire Westside, and (2) the signs tend to get vandalized or damaged if they stay in any given location for too long. Despite these drawbacks, it would be very useful if we could have our own sign to post permanently in the Glen, and I sought, with the help of Officer Blankenship, to arrange for this. Unfortunately, it appears that an engineering speed survey by the Department of Transportation is a prerequisite for radar speed enforcement pursuant to state law, which includes the purchase and installation of a radar sign. Such a survey has never been prepared for our area (hence, the reason that LAPD does not and cannot catch speeders in the Glen using radar guns), and because severe cutbacks to the City's budget have reduced the number of engineers who conduct these surveys, the DOT has been backed up for years trying to process all the requests for speed surveys. I've asked to have N. Beverly Glen Blvd. added to the list, but we shouldn't expect anything to happen on that front in the near future.

To add insult to injury, Officer Blankenship told me that his Captain no longer wants to dedicate any more time or manpower to the Speedwatch Program; so it is being disbanded. Sergeant Kunz, in the Westside office, agrees with that decision. He cited the fact that even when ROBG was active with the Speedwatch Program, he received fewer than a handful of e-mails regarding the results of our speedwatch sessions. At this point, I shall try to contact Officer Blankenship's Captain to see if he can be persuaded to keep the program. According to Officer Blankenship, there are die-hard speedwatchers in the Pacific Palisades who are going to take the discontinuation of the program very hard; so I shall contact the group in the Palisades to discuss joint efforts to lobby for the continuation of the program. There is usually strength in numbers. PLEASE send me any other suggestions.

The traffic on Beverly Glen is a constant source of concern for residents, particularly those who live within the narrower straits of the canyon where not even cars parked on the shoulder of the boulevard are safe. In the short time that I have lived in the Glen, I have witnessed just about every moving violation in

the vehicle code from my own front yard. Time and time again, I see people blatantly running red lights, taking blind bends in the road at excessive and unsafe speeds, veering into the shoulder, and crossing over the double yellow line into oncoming traffic to pass somebody who is driving within the speed limit. It's like the Wild West out here, and it will continue to be unless we all take responsibility to do something about it. We *CAN* make the situation better, but we shall only get additional LAPD enforcement if we ask our Councilman and law enforcement to make our community a priority. Clearly, they have not been hearing from enough of us; so PLEASE, rather than just complaining to your friends and neighbors . . .

Call the West LA Traffic Division at (213) 473-2222. Ask to speak with Sergeant Kunz, and tell him that Beverly Glen is unsafe for our families and that we need additional police presence and traffic enforcement in our neighborhood.

**Call Councilman Paul Koretz's office** at (818) 971-3088, and tell him and his staff the same thing. We need the City's finest to patrol in the Glen more often.

## HILLSIDE FEDERATION UPDATE

### Laurel Canyon Hillslide Cleanup – Emergency

A project to remove the debris from a hill/ mud-slide that occurred over 8 years ago has been proposed. The project will remove thousands of cubic yards of dirt from the slope along Laurel Canyon Boulevard just north of Fountain on the west side of the street. For several years there have simply been K-rails placed in the roadside in this area. Recently this issue has been a contributing factor to more than one fatality along that stretch of Laurel Canyon. The project would require trucks to park on, or along, Laurel. The funding is rumored to be coming from taxpayer dollars. The Hillside Federation has requested more information before making a decision whether to support or oppose this "emergency" project.

# Hillside Federation support for County Wide Pesticide Ban

The Hillside federation has taken a position in support of a new city law to ban the use and sale of Stage 2 Coagulant pesticides. (These types of pesticides do not kill the pest immediately which can contribute to the death of other animal(s) that may consume an infected pest before it dies.)

### Millennium Hollywood

The Hillside Federation was updated on the Millennium Hollywood Project. This mixed-use project would develop 1 million square feet (2 towers approximately 56 stories high) of residential, hotel, office and associated space, including parking. This project will dramatically changing the view of the Santa Monica Mountains and have a significant impact on traffic in the area. A new discovery was that it lies directly on the Hollywood fault line. This project conflicts with the No Habitation Structure Code for seismic issues. Hillside Federation wants lawyers and geologists to intervene.

# IN THE KITCHEN WITH DIANE

1 cup chopped cucumbers (I like the organic Persian variety)

½ cup chopped fresh tomatoes (heirloom if available)

½ cup chopped fresh anise root

1/4 cup chopped fresh parsley

¼ cup chopped fresh mint

2 Tablespoons of fresh thyme leaves (stem removed)

½ cup roasted pine nuts

#### **Dressing:**

Mix together 1 teaspoon fig jam, ¼ cup good quality olive oil, juice of one fresh lemon, one drop of soy sauce, salt and pepper to taste.

Top with the dressing. Toss and add salt and cracked pepper to taste.
